

<u>Provider Feedback:</u> Unless otherwise noted, the following comments are verbatim from providers regarding Quarter 1 expenditures.

- AgeWell Services, Living Word Senior Services, and Volunteer for Dental: Senior
 Resources notes that certain providers have the flexibility to transfer funds between related
 services. AgeWell Services can transfer funds between home-delivered and congregate
 meals, Living Word Senior Services between snow removal and lawn services, and
 Volunteer for Dental among its three dental services.
- **Boys & Girls Club:** At this time BGCML has utilized 18% of its funds since October. Our enrollments have been growing since as we grow our name in the community, and we expect a minimum of \$1,000 per month through September, on track to fulfilling the service expenditures.
- City of Muskegon, City of Muskegon Heights, Love INC, and Trinity Village: Senior Resources notes that home repair providers submit invoices at varying times, with some providers submitting monthly and others accumulating invoices to maintain an average below \$7,000. This can affect reported expenditure percentages and does not necessarily reflect a lack of ongoing projects or reimbursements due.
- Fruitport Lions Club: Senior Resources notes that Senior Power of Produce is seasonal.
- Living Word Senior Services: During the winter season of 2024/2025, Muskegon County has experienced a major increase in snowfall from previous years. Our budget gives us the ability to plow for 130 seniors for a total of 17 times in the season. Through partnerships with 3 townships; Dalton, Fruitland and Fruitport, Living Word Senior Services has funding for 60 additional seniors. This brings the total to 190 seniors that receive snow removal services during each snow event.
 - With the funds rolled over from last season, our budget for 2024/2025 increased to 18 total available pushes. As of January 24th, we have plowed 17 times. This leaves 1 push available with current funds for the remainder of the winter season.
- **Pioneer Resources:** Northern Recreation We have held 4 events to date with 6 additional to be held. Senior Resources notes that the provider is on track to providing all 10 contacted units. Dynamic Transportation Lack of drivers and getting communication out that service is available with the new fiscal year has resulted in lower than expected participation. Numbers have increased thus far for new quarter.

Communications from Senior Resources:

- 22% of the FY25 MCSM awards have been expended, providing services to over 1,600 participants between October 1st and December 31st, 2024. We project near full expenditure of all awarded funds by the end of the fiscal year.
- FY2025 Additional Funding Recommendations: Page 8-10 is a draft of the provider's request for additional funding for FY2025 only. SR recommendations are based on factors such as

- whether the service is a priority, FY23 service levels (prior to funding reductions), and a comparison between the amount requested and what's currently awarded. Funding recommendations will be voted on at the April 15th meeting.
- AgeWell Services has initiated a waitlist for Home-Delivered Meals, excluding priority 1
 participants. When a person is placed on the waitlist, AgeWell Services will first offer a "PrePay, Full-Pay" option. If the individual indicates that they do not have the financial capacity
 to pay the full amount per meal, AgeWell Services will provide them with information on
 other food access programs, such as MDHHS for SNAP benefit enrollment and 211 to
 receive information on area food pantry and distribution locations.
- Living Word Senior Services transferred \$14,620.50 from Lawn Care to Snow Removal to cover additional plowing that happened during the 2024/2025 winter season. No vote is needed.

Dear Muskegon County Senior Resources

During the winter season of 2024/2025, Muskegon County has experienced a major increase in snowfall from previous years. Our budget gives us the ability to plow for 130 seniors for a total of 17 times in the season. Through partnerships with 3 townships; Dalton, Fruitland and Fruitport, Living Word Senior Services has funding for 60 additional seniors. This brings the total to 190 seniors that receive snow removal services during each snow event.

With the funds rolled over from last season, our budget for 2024/2025 increased to 18 total available pushes. As of January 24th, we have plowed 17 times. This leaves 1 push available with current funds for the remainder of the winter season.

We are concerned about the ability to provide this highly important service to the senior constituents for the remainder of the winter season. Our historical average for February and March snow events and subsequent pushes is approximately 4-6 snow events that would be significant enough to necessitate plowing.

Based on our current contract with the county, we have the option of using lawn care funds to help cover additional snow events. To pay the cost of the additional 4-6 snow events would use up over half of our lawn care funds.

We prioritize snow removal over our lawn care but recognize that to use these funds would reduce our available lawncare slots from 100 to 50 seniors.

Living Word Senior Services requests \$15,180.50 to cover the additional costs to plow for the remainder of the 2024/2025 season. In the event that we do not need to access that full amount because of fewer snow events, we fully recognize that those funds would not roll over to any additional year.
