Dear Pam,

AgeWell Services of West Michigan would like to request a reallocation of \$19,907.72 from the Senior Millage Congregate Funds to the Senior Millage Home Delivered Meals Funds for fiscal year 2024-2025. This will move 2,065 meals from Congregate funds (at the current congregate reimbursement rate of \$9.64) to become 2,148 home delivered meals (at the current home delivered reimbursement rate of \$9.27).

Funds designated as congregate were used sparingly during the year knowing that the greatest need would be for home delivered meals. We appreciate the flexibility that the Committee grants AgeWell in determining the best usage for funds allocated for meal services. AgeWell is equally appreciative of our business relationship with Senior Resources.


